Overview

The Calgary Airport Authority ("The Authority") recognizes that supporting environmentally responsible and sustainable airport operations and development adds value to the aviation sector and our community. As such, The Authority is committed to operating and developing YYC Calgary International Airport and YBW Springbank Airport in an environmentally responsible and sustainable manner. The Authority will implement and maintain standards, procedures, documentation, and direct resources to support the achievement of this objective.

Scope

The purpose of this Policy is to identify The Authority's corporate commitment and direction for environmentally responsible and sustainable airport operations and development. The Policy applies to all activities related to the operation and development of both airports, our work with communities and stakeholders, and is intended to guide the actions of the Authority's employees, contractors, airport users and tenants.

Commitments

The Authority will:

- 1. Comply with all environmental legislation, legal requirements and sustainability commitments adopted by The Authority applicable to airport development and operations.
- 2. Implement programs, projects and procedures to conserve natural resources, prevent pollution and limit waste generation.
- 3. Monitor and report on environmental elements and sustainability performance including the effectiveness of supporting standards and procedures.
- 4. Provide communication on the Authority's environmental and sustainability performance and initiatives with all stakeholders, including Authority employees, contractors, suppliers, tenants, airport users, applicable government departments and the community.
- 5. Provide ongoing training and awareness activities that enable and improve the capacity of Authority employees, contractors, suppliers, tenants, airport users, applicable government departments and the community to support the goals of this policy.
- 6. Include environmental and sustainability considerations in Authority decisions related to land use planning, airport development, resource planning and corporate strategy.
- 7. Implement and maintain environmental and sustainability objectives and targets aimed at continuous improvement focusing on:
 - a. Greenhouse gas emission reduction;
 - b. Waste reduction;
 - c. Water use reduction
 - d. Environmental protection and ecosystem health;
 - e. Environmentally responsible, handling and use of materials and resources used in airport operations and development; and
 - f. Other areas of environmental and sustainability performance goals as they become prioritized by The Authority.
- 8. Consider the environmental and sustainability performance of our suppliers and the environmental attributes of products and services during the procurement process.
- 9. Routinely monitor Authority environmental and sustainability performance through inspections, reviews and audits to verify compliance with this Policy and, where necessary, ensure effective corrective measures are implemented.
