

## THE CALGARY AIRPORT AUTHORITY STANDARD CONTEST RULES

### (The "**Rules**")

These rules govern the contests and giveaways (collectively, the "**Contests**" each a "**Contest**") administered by the Calgary Airport Authority (the "**Authority**"). The Contests are conducted in the Province of Alberta and are subject to applicable municipal, provincial, and federal laws, including the *Competition Act* (Canada) and the *Alberta Personal Information Protection Act* (PIPA).

**No purchase is necessary.** Contests are void where prohibited by law. Participation in a Contest constitutes acceptance of these official Contest Rules (the "**Rules**").

### PARKYYC x THE CALGARY FLAMES GIVEAWAY (the "**Contest**")

#### 1. ELIGIBILITY

To be eligible to enter the Contest, an individual must:

- Be a legal resident of Alberta and have reached the age of majority (18 years or older).

Employees, officers, directors, representatives, and agents of the Authority, its parent, related and affiliated companies, subsidiaries, departments or agencies, franchisees, suppliers, advertising and promotional agencies, Contest administrators, and any other parties engaged in the development, production, or distribution of Contest materials, and those living in the same household, whether related or not, are not eligible to enter this Contest. By participating in this Contest, entrants acknowledge compliance with, and agree to be bound by these Contest Rules. Entrants who do not comply with any of the Contest Rules are subject to disqualification by the Authority, in its sole discretion.

#### 2. CONTEST PERIOD

The Contest entry period (the "**Contest Period**") will begin on March 10, 2025, and will end on March 31, 2025, after which time the Contest will be closed and no further entries will be accepted.

#### 3. HOW TO ENTER

(a) No purchase necessary. To enter, go to [www.yyc.com/en-us/flamesprizedraw](http://www.yyc.com/en-us/flamesprizedraw) and complete one of the two following actions:

1. Complete the online entry form and opt into the Park YYC mailing list; or

Receipt of an online entry occurs when the Authority's server records the entry information. Receipt of a mail-in/email entry occurs when the Authority contact for the Contest receives the entry and records the entry information. All entries must be complete and are subject to verification by the Authority in its sole discretion.

(b) Entry Limit: There is a limit of one (1) entry per person per Contest Period unless otherwise specified. Additional entries will be void.

(c) Entry Ownership: All entries become the property of the Authority and will not be returned. Late, illegible, incomplete, damaged, fraudulent, or otherwise invalid entries will be disqualified.

Any attempt or suspected attempt to use robotic, automatic, programmed, or otherwise illicit means to enter the Contest, or any other methods not authorized by these Contest Rules, including but not limited to creating multiple accounts, identities, or registrations, all in the Authority's sole discretion, shall be deemed as tampering and may disqualify the entrant from entering, participating, and/or winning a prize. Entries that contain false or incomplete information are void. Entries that are late, lost, stolen, illegible, damaged, misdirected, mutilated, garbled, or otherwise irregular, or that do not conform with or satisfy any or all of the conditions of the Contest Rules, are void. No correspondence will be entered into except with selected entrants. Proof of transmission (e.g., screenshots or captures) does not constitute proof of entry or receipt of an entry.

#### **4. PRIZES**

(a) Contest Prizes (collectively, the "**Contest Prize**"):

- One (1) Dustin Wolf Calgary Flames Jersey (Approximate Retail Value: \$280.00)
- Four (4) regular season Calgary Flames Tickets to their April 5, 2025 game against the Las Vegas Golden Knights (Approximate Retail Value: \$980.00) \*

**\*NOTE:** Ticket holders must be prepared to attend the game in-person at the Scotiabank Saddledome in Calgary, Alberta, to validate their tickets. The Contest Prize does not include accommodations, meals, or any other expenses associated with game attendance.

(b) Contest Prize Conditions:

- The Contest Prize is transferable but cannot be sold, refunded, or exchanged for cash.
- The Contest Prize cannot be combined with other discounts, promotions, or special offers.
- If unavailable, the Authority reserves the right to substitute the Contest Prize with an alternative prize of equal or greater value at its sole discretion.

(d) Contest Prize Distribution: The winner will be contacted with instructions on how to claim the Contest Prize. The Authority is committed to distributing the Contest Prize without undue delay, in compliance with the *Competition Act* (Canada).

(e) Authority's Liability: The Authority is not responsible for loss, damage, or misdirection of the Contest Prize.

## **5. WINNER SELECTION**

(a) Odds of Winning: The odds of winning depend on the number of eligible entries received before the Contest End Date.

(b) Winner Selection Process: A random draw will be conducted on Tuesday, April 1, 2025, at 2000 Airport Road NE, Calgary, Alberta. If the selected entrant does not meet eligibility criteria, another entrant will be drawn.

(c) Notification: The selected entrant will be contacted via telephone and email within two (2) business days. If unreachable after three attempts, another entrant may be selected.

(d) Winner Requirements: The selected entrant must:

1. Correctly answer a skill-testing question as required by the *Criminal Code of Canada*.
2. Sign and return the Declaration of Eligibility and Liability/Publicity Release form.
3. Comply with all Contest Rules.

(e) Verification: The Authority reserves the right to verify the identity and eligibility of any entrant at any time. Failure to provide such proof may result in disqualification.

## **6. RELEASE & INDEMNIFICATION**

By choosing to enter the Contest, each entrant:

- Releases and holds harmless the Authority and its affiliates from any liability arising from participation in the Contest or use of the Contest Prize.
- Agrees to indemnify the Authority against any claims related to their entry.

## **7. LIMITATION OF LIABILITY**

The Authority is not responsible for:

- Technical malfunctions or errors affecting the entry process.
- Lost, late, or misdirected entries.
- Any injury or damage resulting from Contest participation or use of the Contest Prize.

If the Contest cannot be conducted as planned due to fraud, technical issues, or unforeseen circumstances, the Authority reserves the right to cancel, suspend, or modify the Contest.

## **8. PRIVACY & USE OF PERSONAL INFORMATION**

By entering, participants consent to the Authority using their personal information for:

- Contest administration (including contacting winners).
- Publicity and promotional purposes.

The Authority will handle all personal information in accordance with Alberta's *Personal Information Protection Act (PIPA)* and its privacy policy.

## **9. GOVERNING LAW**

The Contest is void where prohibited by law and is subject to all applicable Canadian federal, provincial, territorial, and municipal laws. The Contest shall be governed exclusively by the laws of the Province of Alberta. Any dispute shall be adjudicated in the courts of Calgary, Alberta.

## **10. INTELLECTUAL PROPERTY**

All intellectual property associated with the Contest is owned by the Authority. Unauthorized use is strictly prohibited.
